Help Sheet: Safeguarding Training Video Courses

All video courses used for Safeguarding training in the diocese are posted on the Praesidium Academy website. The Safeguarding Office assigns certain video courses as required training for persons who hold a particular position in an organization. These video courses may be taken in Spanish or English. All Safeguarding applicants who are approved for training will receive an email with instructions for accessing the required videos.

Other videos posted on Praesidium Academy may be recommended by the diocese for a position, but they are **not required**. The **Safeguarding Records System (SRS) does not track the completion of these videos** or count them toward training requirements, even if an organization chooses to require an employee or volunteer to take a recommended video course.

In addition to the required and recommended videos, the Praesidium Academy website contains other video courses that are available to users who choose to take the courses or who are required to take such videos by an organization. SRS does not track the completion of these videos or count them toward meeting Safeguarding requirements.
